- All Contractors who are registered with Pakistan Engineering Council (PEC) in Category C-4 or Above Can Participate in Open E-Tendering System. Procurement Procedure strictly is adopted in accordance with PPRA Rules 2014 (with up to date amendments). Contractors can participate in E-Tendering after fulfilling following terms & conditions.
 - a) Contractor/bidder has to upload scanned copies of call deposit Receipt (CDR) @ 5% of the estimated cost of any Scheduled bank, Original CDR Deposit at Call in favor of **Treasurer, University of Veterinary & Animal Sciences Lahore** must be submitted to the office of undersigned on tender opening date before closing time. Tender will be received 10.09.2025 at 11:00 AM and Tender will be opened 10.09.2025 at 11:30 AM.
 - b) Tender **single stage Single Envelope** will be opened in the office of Project Director, **University of Veterinary & Animal Sciences, Lahore** in the presence of Tenders Opening Committee and Contractors or their representative by using E-Procurement portal of only those applicants who are clear in scrutiny of documents, no provisional applications will be acceptable.
 - c) All the contractors participating in E-Tendering will be bound to submit their Original CDRs, with letter heads in the office of the undersigned. Otherwise, the contractor will be declared as disqualified in the presence of Tender Opening Committee.
 - d) The Contractors / Firms wishing to Participate in the bidding process shall also attached valid registration with the Pakistan Engineering Council for the year 2024-2025 in the specified category and discipline, along with government receipts for payment of professional tax, CNIC, registration with the Punjab revenue authority (PRA) for the year 2024-25 with the bidding document.
 - e) In case of false information, fake CDR & Fake tender fee Challan, the contractor will be liable to be disqualified as per PPRA Rules and will not be eligible to participate in upcoming tenders of, **University of Veterinary & Animal Sciences, Lahore**. Further his case will be forwarded to PEC and PPRA for Initiation of Strict Legal Action.
