MINUTES OF THE EIGHTEENTH MEETING OF PHASE I & II QUALITY ENHANCEMENT CELLS

A two day meeting of Heads of Quality Enhancement Cells of Phase I & II was held on $15^{th} - 16^{th}$ April, 2013 at HEC Regional Center, Lahore wherein representatives of 27 QECs briefed about the problems encountered in conducting teachers' and course evaluation; remedial actions taken on weaknesses identified by the evaluations and new good practices introduced by QECs in their respective universities.

On the second day, a case study on progress developments in QEC was presented by National University of Science and Technology Islamabad and University of Punjab Lahore. In addition, representative of Virtual University of Pakistan, Lahore delivered a brief session on Service Quality in Education.

Liaquat University of Medical and Health Sciences, Jamshoro didn't deliver/provide their presentation.

4. During the inaugural speech, Managing Director (QAA) welcomed the participants and appreciated their efforts to promote the quality assurance mechanism in their universities. He informed that although the implementation of the Self- Assessment Process has taken roots, but continuous input is still required to fully achieve the objectives of strengthening the internal quality assurance processes. Managing Director (QAA) informed QECs that a third party evaluation will be carried by either local or foreign experts to monitor the progress of the QECs with respect to Self-Assessment as suggested by the World Bank. Therefore, the QECs should work hard to remove their deficiencies and try to achieve the desired results. Furthermore, the

QECs should not neglect the teachers' and course evaluation surveys as it is an essential part of the scorecard and SARs.

- **5 (a)** Summary of the problems encountered in conducting the teachers' and course evaluation are as follow:
 - a) Lack of resources.
 - b) Lack of interest by the students in providing realistic feedback.
 - c) Lack of interest by the faculty and program teams due to work load and other unforeseen reasons.
 - d) Teacher and course evaluation is considered as a lengthy process.
 - e) Insufficient staff and confronting difficulty in manual data entry.
 - f) Complicated survey proformae, irrelevant/ambiguous questions in the proformae.
 - **(b)** Summary of the remedial actions taken on weaknesses identified by the evaluations is as follow.
 - a) Revision of curriculum for programs.
 - b) Changes in the order of the offering of some of the courses and rationalizing the course contents and addition of new courses.
 - c) Notifying HRD and HR about weak faculty and arranging counseling sessions for them.
 - d) Study tours arranged for research students
 - e) QEC conducts regular meetings regarding Comprehensive Evaluation Report. The meeting includes Vice Chancellor, Deans, Registrar and Director QEC.
 - f) Visiting faculty members having low evaluation are not invited to take any course in future.
 - g) Appreciation letters are awarded to the faculty members with good evaluation report.
 - h) Course Files are prepared & updated by faculty regularly and checked by QEC.
 - **(c)** Summary of new good practices introduced by QECs in their respective institutes is as follow:
 - a) Checking of classes
 - b) Review of Course Files
 - c) Evaluation for best teacher award
 - d) Monitor the Examination
 - e) Plagiarism checking
 - f) QECs look after the Accreditation processes of the programs.
 - g) Coordination with employers to get feedback of employer survey
 - h) TTS evaluations

- **6.** During the discussion session the following suggestions were made pertaining to evaluation surveys and Self-Assessment mechanism.
 - a) The QECs should also focus on the programs for Self-Assessment for which evaluation has not been initiated, in conjunction with initiation of 2nd cycle of SA process for programs where the 1st cycle has already been completed. The purpose is to address all the programs being offered in the HEIs.
 - b) QECs should coordinate with each other either via QEC Yahoo Network or individually to share the good practices being introduced in their respective institutes.
 - c) Feedback system can be developed with collaboration of QECs where they have a well-developed system.
 - d) Case study has to be submitted by QECs regarding hindrances in the QECs establishment, staff appointment, initiation of SA exercise and conducting surveys.
